Law firms are on the frontline in the battle against online adversaries. They represent attractive targets for data theft and ransom, due to the highly sensitive client information they store and low tolerance for system outages. That puts the spotlight on email, the primary communication tool of business and vector for digital threats.

For IT managers working in the sector, email threats aren't the only risk that needs to be carefully managed. Effective backup and archiving are also essential for compliance and e-discovery purposes.

Fortunately, LCA IT Manager, Fabio Colombo, found in Barracuda a partner he could trust to handle all of these business-critical capabilities from a single email security suite.

Time to change

Fabio was dissatisfied with his former backup and archiving solutions. He notes users are not always able to find what they're looking for when using native archiving in Microsoft Outlook. And a previous on-premises backup solution was difficult to manage and exposed the company to potential business continuity risks. For backup at least, a high degree of usability and coverage across Microsoft 365 data was deemed essential.

"It was important that I didn't have too many dashboards for managing everything," says Fabio.

He was also unimpressed by a previous anti-spam solution, which suffered from false positives and required a high degree of manual effort to operate, especially in terms of incident response.

"During a demo of Barracuda, I saw how to do things in a better, simpler and faster way," Fabio explains. "So I tried to push internally for the Barracuda solution, and to adopt it over a multi-year period for financial reasons."

A total solution

In the end, LCA purchased [Barracuda Email Protection](#): a comprehensive suite of products designed to help organizations prevent, detect and respond to email threats, as well as backup and archive critical data. It features a powerful AI engine that uses relationship graphing, natural language processing, pattern recognition, and anomaly detection to continuously analyze and remediate malicious inbox emails in real-time. In addition, it leverages Advance Threat Protection (ATP), combining behavioral, heuristic, and sandboxing technologies to protect against advanced malware and ransomware. Any threats that sneak into inboxes can be swiftly removed with [Incident Response](#), which is designed to accelerate and automate the process of threat hunting across mailboxes.

The solution also offers [Cloud Archiving](#), with granular retention and powerful e-discovery as well as [Cloud-to-Cloud Backup](#), which offers unlimited storage and retention for Exchange Online, SharePoint Online, OneDrive for Business, and Teams data.

Deployment was as straightforward as it gets for Fabio and his team.

"It was extremely simple," he says. "We had a call with Barracuda and, more or less, the job was done in an hour."

“I monitor it constantly because I like it, but it actually works well independently,” he says.

Fabio explains that Impersonation Protection has helped by alerting when threat actors attempt to insert themselves into conversations between two lawyers, protecting LCA from potentially serious information theft.

“I don’t need to configure anything manually because Barracuda speaks so naturally with Microsoft 365,” he adds.

There’s also a great deal of threat and user information in the dashboard which Fabio and his team can click down into to enhance their security posture and gain greater awareness of the threat landscape.

All eyes on XDR

Aside from making more use of [Security Awareness Training](#), another powerful feature of the platform, LCA is keen to put [Barracuda Managed XDR](#) on its roadmap.

“We have another solution, and the contract ends in 2026. At that moment we can try to integrate the function into our Barracuda console,” Fabio says. “It will be great to get SOAR functionality for automated threat response via our firewall.”
